On the above date, at approximately 0229 hours, I responded to an emergency call referencing an auto accident with injuries at the above stated address. I arrived on scene at 0233 hours. Upon my arrival, I observed a black male lying in the roadway not moving, covered in a blanket and resting his head on a pillow. There was a white female kneeling over the subject (later identified to be the wife: Elin Nordegren). I made contact with the subject, known to be Tiger Woods.

My immediate observations were that of an unresponsive male subject, breathing adequately with lacerations to the lips and noticeable blood in the mouth. Mr. Woods was not responsive. I conducted a brief physical assessment and nothing stood out to be immediately alarming. Mr. Woods periodically attempted to get up; for his safety, I kept him lying down, using the pillow to immobilize his cervical spinal column.

An Orange County Sheriff's Deputy and Orange County Fire Rescue Engine 35 arrived on scene at approximately 0238 hours; OCFRD took over care of the patient. I then observed the vehicle, a black 2009 Cadillac Escalade still in contact with a tree. The contact was to the front passenger side of the vehicle. The airbags were not deployed, and both rear door windows were broken out; glass was on the driveway adjacent to the vehicle's broken windows. The engine of the vehicle was on. There was a fire hydrant approximately 5ft behind the vehicle broken out of the ground. There were two golf clubs (irons) lying on the ground next to a white golf cart which was also in the roadway.

Florida Highway Patrol arrived on scene to conduct the accident investigation after the patient had been transported to Health Central Hospital. I assisted in clearing the vehicle of belongings (in preparation of tow) and placing them in the patient's garage, which was the residence next door. In the process of clearing the vehicle of belongings, I initially attempted to enter the vehicle by means of the front passenger door. The door (front passenger) would not open and appeared to be jammed shut from the passenger side front quarter panel being crumpled into the door hinges. Officer Sipos counted \$235.00 from the center console and was placed it into a traffic envelope. The FHP trooper placed the sealed envelope in the garage with the other belongings.
